Subject: Uploading the quality grading of items/sub-items and photographs of works inspected under 2nd tier of quality monitoring.

Dear Sir,

Kindly refer to the circular no. 6/2011, dated 28th April, 2011 issued by Ministry of Rural Development on the subject cited above. With a view to ensure that all SQM reports are mandatorily entered in OMMAS, it was decided to take following action w.e.f 1st May, 2011.

- i. SQM reports would not be recognized unless requisite grading of item/sub-item under 2nd tier are uploaded in OMMAS.
 - ii. Each SQM report should also cover at least 10 digital photographs to be uploaded on OMMAS.
 - iii. In quarterly report QPR-QM-2, the State should indicate only those SQM reports which are uploaded in OMMAS.
2. I would also like to bring to your kind notice in this context that the Ministry vide its letter dated 11th March, 2011 has also indicated that the release of programme fund would be contingent upon uploading of gist of SQM reports and photographs on the website.
3. An abstract of SQM reports entered in OMMAS and the corresponding number of photographs uploaded for the inspections carried out during the period May to July, 2011 is attached as **Annexure-I**.
4. In view of above, I would request you to kindly review the uploading status of SQM reports in OMMAS vis-à-vis details given in the Annexure.

5. I would be grateful if you could kindly issue necessary directions to ensure that abstract of all SQM Inspections along with 10 digital photographs for each inspection, is mandatorily upload in OMMAS within stipulated time and only such reports which are uploaded in OMMAS should be tabulated in QPR-QM2 format while reporting.
