OFFICE ORDER

It is observed that there is slackness in 'Monitoring & Action Taken' on sub standard test reports of Quality Control Divisions at Zone level. It is usually seen that the action taken reports are not submitted to Head office by ACE in compliance to this office letter no. CE&AS/ SE (B)/EE(SI&QC)/D-1532. Dt. 17.06.2008.

There was a review of the above matter at Govt. level. The directions are hereby issued on approval of the proposal by the Govt, vide ID No. Pr.S., PWD /1633 dated 14.09.2009 as under:

- It is directed once again that the monitoring of action taken reports on sub standard works shall be dealt with at the level of Additional Chief Engineer.
- It is directed that EE(SI&QC) has to submit the inspection report of sub standard tests to the concerned field officers within 7 days positively & copy to SE/Addl. CE.
- It is also directed that the action taken report on rectification of sub standard tests of works will be submitted by concerned EE to their SE / ACE within 15 days positively.
- If any field officer fails to take action on sub standard test within time then action shall be taken against the defaulter.
- It is directed that the monthly compiled action taken report on sub standard tests of works should reach to Secretary, PWD, by 20th of every month positively under intimation to Head Office.
- It is also directed that in future for sub-standard works SI&QC Divisional staff shall also be equally held responsible with the concerned field staff for any type of negligence in their duties for quality assurance of works. Therefore they have to be more cautious for (a) Regular inspection on all works (b) Testing for all activities as per norms (c) Timely submission of correct & complete-inspection report for sub standard tests of works to the field officers.

This order will supersede all the previous related orders and it will be enforced with immediate effect.
