I If any of the above mentioned details are not found to the satisfaction of RSRDC, at any point of time, after registration or requisite details are not got modified/upgraded/updated by 30th June of Every Year, I/We may be black listed for 01 year or My/Our registration may be suspended for 01 year, as finalised by RSRDC.
